

## Breed First - Obedience Trial Champion (OTCH)

The competitive edge in all of us makes us hope for that one special dog. Rarely, but sometimes, that dream comes true; we become part of a unique team and travel the road to excellence. "Brandi" (Highpoint Mundy's Muse) and I had that kind of relationship.

We brought Brandi into our home when she was only 5½ week old. Play training started when she was about 10 weeks old—very basic exercises such as sit, down, come and stay. By the time she was about a year old she was trained through Open. Jump heights at this young age were kept to a minimum. I did not have her jump full height (26") until she was about 1½ years old.

In the beginning of 1982 we went to our first AKC obedience trial—the Bayshore Companion Dog Training Club. I knew Brandi was capable of doing a good job, but was not sure how she would react to all the people, dogs, and other distractions.

She did a commendable job at Bayshore—a score of 197½ and fifth place overall from a very large Novice class. Her next two shows earned us scores of 197 (1<sup>st</sup> Prize), and a 198½ (2<sup>nd</sup> Prize). These high scores in three straight shows earned Brandi a Dog World Award.

By the summer of 1982, Brandi was showing great promise in her Open training. By the fall of the year, I decided it was time to think about trying for her Companion Dog Excellent (CDX). In November, off we went; four shows, 4 qualifying scores and three first prizes.

Much of 1983 was devoted to teaching Brandi the Utility exercises. Several times, however, I stopped Utility training and switched back to her Open work. Because of her high scores in Open she had qualified for the '83 Gaines Regional Obedience Competition (to qualify one must obtain three scores averaging 193 or better). September '83, found us in Greenville, South Carolina competing against some of the top obedience dogs in the country. It was a real thrill to be participating in the Eastern Regional with a fast, precise, happy working Saint Bernard—among all those Golden Retrievers, Border Collies, and Shelties. Brandi made quite an impression on spectators and judges! And after the three classes were done she had moved up in the placings to tenth place making her eligible for the 1983 Gaines Classic in California. (I opted not to participate because of the stress Brandi would be subjected to, due to the long flight to California.)

Alternating between Utility and Open before the Regional was hard on Brandi. However, by January 1984, she had a good understanding of Utility—good enough to enter her first trial (at Princeton Dog Training Club) and earn her first Utility leg. In her enthusiasm to complete all the exercises, she was not as precise as I would have liked, but a qualifying score of 188 points at our first trial in Utility A was still a job well done.

By March 1984, Brandi had earned her UD—in only five trials. Now it was on to the big time—a try for an Obedience Trial Championship. Competing against all of the top competitors in Open B and Utility B was a little scary at first, but it did not take long before I realized she could hold her own. For almost 1½ years we were on the road every weekend traveling up and down the East Coast. Not an easy task for someone with a family, a full-time job, several other animals to care for, an orchestra to play in, and instructing obedience training classes at Princeton Dog Training Club. (At the end of 1984 we had earned 13 OTCH points, in November 1985 we had 66 points, and on May 31, 1986 we earned our 100<sup>th</sup> point!) The points came no more than ten at a time, usually no more than two or four. Many weekends, after two shows and two classes each day, we came home with no additional points. Dedication, however, does pay off—we did it—we earned those 100 necessary points.

Brandi also has some breed points to her credit. However, an untimely bout with pyometra in 1984 ended her career in the breed ring.

During intensive training for almost anything, problems do crop up. Brandi's biggest problem has been and probably always will be her fear of ring gates. Anybody who has trained dogs realizes how hard it is to work out a problem caused by fear. The exercise that has suffered the most because of her "ring gate phobia" was the send out in the Utility Directed Jumping exercise. We have persevered, however. Patience, firmness, and praise during Brandi's training have helped her through the problem.

Brandi, besides her short career in the breed ring and her extensive obedience career, has done some advertising for Milk-Bone, Aspen Leaf in Colorado, Reader's Digest, and a bank in South Carolina. We were also featured, in 1983, with two other Gaines Regional Winners on "Saturday Morning Live" on Channel 5 TV in New York.

It was an extreme pleasure to be on Brandi's team. We were devoted to each other and it showed. She tried extremely hard to please me. That kind of commitment from her was extremely important down the long road to the OTCH. "My heart goes out to you Big Dog!"
